- Click generate invoice
- Select Identity (Individual, cooperate, federal Agency, State Agency)
- Search for tax to make payment
- Create PAYER PROFILE by entering details of PAYER and PROCEED
- Enter the right amount and confirm the Invoice.
- Make payment using invoice number which is BIN: \*\*\*\*\* as an account number using any convenient payment method (e.g Bank transfer, POS, online banking etc).
- Download Payment Receipt.
